With regard to Material, Recipient hereby agrees:

- (1) not to use Material except to the extent required to accomplish the Purpose of Transfer;
- (2) not to transfer Material to others (except to its employees with a need to know and who are bound by the terms of this Agreement) without the express written permission of Provider;
- (3) to safeguard Material against disclosure and transmission to others with the same degree of care as it exercises with its own materials of a similar nature;
- (4) at Recipient's expense, to destroy or return, as directed by Provider, all Material upon Provider's request;
- (5) that the Material is experimental in nature, and is provided by Provider "as is" without warranty of any kind, express or implied; that except to the extent prohibited by law, Recipient assumes all liability for damages which may arise

- from its use, storage, or disposal of the Material, except to the extent that such liability arises from the negligence or willful misconduct of Provider;
- (6) that the furnishing of Material to Recipient constitutes neither any transfer of ownership nor any grant or license to Recipient under any patent or other proprietary rights now or in the future held by Provider.
- (7) This Agreement embodies the entire and final understanding of the parties on this subject. It supersedes any previous representations, agreements, or understandings, whether oral or written. No amendment or modification hereof shall be valid or binding upon the parties unless made in writing and signed by an authorized representative on behalf of each party.
- (8) This Agreement shall be interpreted and enforced under the laws of California, without giving effect to any choice of law rules that would

result in the application of laws of any jurisdiction other than California.

(9) In view of its management by an institution education operating under of Fundamental Research Exclusion, Berkeley Lab hereby notifies the other parties that it has many foreign nationals who are students or employees to transfer of Material and/or including export-controlled items. without limitation, products, materials, software or technical information ("items"), may be in violation of U.S. and export control sanction regulations. Accordingly, parties should not transfer to Berkeley Lab any Material and/or items with a U.S. Export Control Classification Number ("U.S. ECCN") other than EAR99 under the Export Administration Regulations, without prior written authorization from Berkeley Lab's Export Compliance Office. responsibility Berkeley Lab bears no

unauthorized exports of non-EAR99 items by a party under this Agreement to Berkeley Lab's foreign students or employees when such written authorization is not obtaine □d. Each party shall abide by the applicable U.S. export and sanction regulations.
